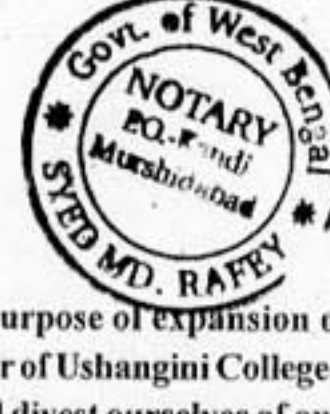

The Secretary is hereby authorized to mutate the property in question described in the schedule below in the name of the College and the donors have no objection to that. Be it mentioned here that if for any reason the proposed College is not established in future, the said property will revert to the donors and they would be the owners and possessors of the same.

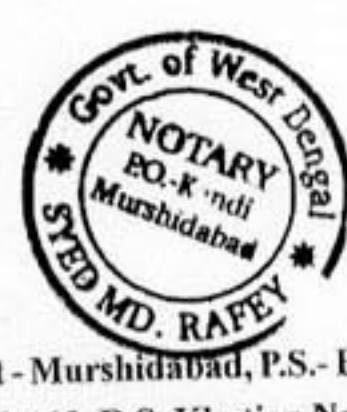
